Residency at K3, Hambourg (Germany)

ABOUT K3

The programming of K3 – Centre for Choreography | Tanzplan Hamburg focuses on artistic residencies that combine artistic research and production, offering classes and training for dance practitioners as well as promoting the fields of education in dance and in culture in general. The choreographic centre at Kampnagel is one of the few dance houses in the German-speaking region and the only one in northern Germany.

K3 offers local and international choreographers various residencies at different points in their careers. The aim is to combine artistic research, production and presentation in order to overcome traditional production rhythms. For years, K3 has been initiating and promoting temporary exchanges of dance professionals, with Hamburg-based artists moving to partner organisations abroad and choreographers and dancers coming to Hamburg from all over the world.

CALENDAR AND CONDITIONS

Who: independent, professional choreographer (2 pieces minimum requested, but this criterion is flexible); must be registered (place of residence) in an EU-country but Germany

What: one-month (research) residency, not result-driven

Time: month of August 2024 // 4 weeks

K3 offers:

3 studios are available: to be shared with other choreographers in residence at the same time

A framework programme compiled by K3:

- workshop programme,
- opportunities to exchange with other peers that are also present in residency programme,
- meetings with dramaturge Niklaus and project coordinator Florence throughout the residency,
- possibility to visit shows, concerts, parties at the Internationale Sommerfestival Kampnagel,
- a three-day workshop programme “Get it On” towards the end of the residency; with possibility to share in an informal showing/workshop etc. what one has worked on during the time at K3

K3 and TROIS C-L offer:

- accommodation in Hamburg
- 350 € lump sum for travel costs (travelling by airplane is only allowed in exceptional and well justified cases)
- compensation of 2.000 euros in total for the whole residency period

This residency at K3 is made possible with the financial assistance of the European Union.

SELECTION CRITERIA AND MODALITIES

To be selected, choreographers must meet the following criteria :

- be independent and/or based on a non-commercial association;
- be of Luxembourg nationality and reside abroad OR be a resident of the Grand Duchy of Luxembourg OR be active in the Grand Duchy of Luxembourg or have been established as a non-profit organisation for at least 2 years;
- in all cases: participate in the development of the choreographic scene in Luxembourg for at least two years.

Applicants must commit themselves to being fully available during the period requested. Applicants agree to abide by the conditions of submission of the project and to fully accept the conditions established between TROIS C-L and the partner.

TROIS C-L reserves itself the right not to consider the application if the criteria and conditions of eligibility are not respected or if the application is incomplete. TROIS C-L reserves itself the right to make a first selection of candidates according to the respect of the criteria and eligibility conditions in order to send a proposal to the partner, who will be the only one to decide on the candidate selected to participate in this project. The decision of the partner is irrevocable.

APPLICATION

Interested candidates must provide :

- A letter of motivation & a written presentation of the project (1 page maximum)
- A portfolio (in English)
- An CV (in English)
- Links to video material (to describe the artistic universe)
- A proof of legal residence

The application must be written in English.
